A. General Fund Levy - Elementary District #3

Facts to Consider: School districts must obtain voter approval for an increase in the number of dollars budgeted for the over-BASE tax levy. The proposition lists an approximate number of mills, since taxable valuation and other information necessary to determine an exact number of mills are not available at the time of the election. Actual mills will commonly differ from this estimate. Shall the electors grant the Board of Trustees of School District #3 to impose an increase in local taxes to support the general fund the amount shall be \$162,320.41 per year, which is approximately 23.48 mills. Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$31.70 and on a home with a market value of \$200,000 by approximately \$63.40. The durational limit of the levy is permanent once approved by the voters.

Superintendent Recommendation: Do not approve the resolution for the General Fund Levy election for SY2020.

Facts to Consider: Refer to pertinent information above. Shall the electors grant the Board of Trustees of School District #3 to impose an increase in local taxes to support the general fund the amount shall be \$76,415.38 per year, which is approximately 9.20 mills. Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$12.43 and on a home with a market value of \$200,000 by approximately \$24.85. The durational limit of the levy is permanent once approved by the voters.
